



IN CASE OF LOSS

Reporting deadlines

In the event that more than 5 business days (for USA: 15 days) pass without the tracking being scanned by the carrier, we will file a claim with the carrier to track down the lost package (usually we receive a response within 8 business days). Before starting any refund procedure we must wait for the carrier to confirm the loss.

Refunding conditions

You have subscribed our insurance: once we have received confirmation of loss from the carrier, we will issue a refund for the full insured value.

<u>You have not subscribed our insurance</u>: we will open a claim with the courier and, depending on their conclusions, we will refund the amount allocated by the courier (see Terms and Conditions on page 17). We usually receive the investigation result within 3 months from the opening of the claim.

IN CASE OF DAMAGES TO THE PRODUCTS

Reporting Deadlines

Any damage must be reported within 5 business days from the delivery date. After this period, the request for reimbursement will not be reviewed by our insurance and no refund can be established.

Documents

- A photo showing the bottles damaged, inside the original box, with all original protection materials
- A photo of the packing material used inside the box
- A close-up photo of the shipping label on the damaged package showing the tracking number
- A photo of the bottles received to enable us to register on the inventory the broken bottles (comparing this to information supplied on the commercial invoice initially provided)

Refunding conditions

<u>You have subscribed our insurance</u>: Once we have received all the requested documents above and identified the damaged bottles, we will issue a refund for the full insured value. NB. insurance does not cover stained or torn labels. <u>You have not subscribed our insurance</u>: we will open a claim with the courier and, depending on their conclusions, we will refund the amount allocated by the courier (see Terms and Conditions on page 17). We usually receive the investigation result within 3 months from the opening of the claim.

NON-REFUNDABLE DAMAGES

Couriers do not consider as refundable the damages:

- due to temperature changes while the shipment is in transit. It is suggested to avoid shipping, especially in the summer, to states with frequent extreme temperatures;
- to wax capsules;
- to labels.

Our price lists include pickup (if your company is located in one of the areas covered by our drivers, as indicated on page 3), packaging in certified wine shipping boxes and customs duties on wine shipments to the United States. For other destinations, where applicable, customs duties will be charged to the recipient unless otherwise specified in the documentation provided to us.

PICK-UPS

Requests must be sent via email to your designated service center (see page 3). Our team must receive the request by 4:00 PM on the day before pickup; otherwise, we cannot guarantee collection.

To facilitate shipment management, please mark the carton with the recipient's name. If shipping multiple cartons to the same recipient, indicate the package number and total number of cartons in the shipment (e.g., 1/2, 2/2). The total number of cartons must also be indicated on the MOS.

You may deliver bottles in their original cartons, as they will be shipped in our certified packaging. If our staff cannot clearly identify the cartons, shipments may be delayed.

Wooden cases are shipped empty, separately from the bottles.

Please clearly indicate the request for wooden cases on the shipping form; otherwise, delivery to the destination cannot be guaranteed.



GENERAL TRANSPORT CONDITIONS

The customer assigns FIERAMENTE SRL (hereinafter referred to as FIERAMENTE) to arrange the delivery of their parcel to the courier:

FIERAMENTE will oversee the parcel's delivery to the destination and sign the relevant waybill on behalf of the customer, who acknowledges being aware of the transport conditions as available at the web addresses listed above.

In this regard, the customer is invited to read and/or download the PDF version of the aforementioned General Conditions and, if necessary, retain them, which is also their responsibility. By accepting the conditions of this price list, the customer confirms that they will independently take care of this matter. Parcels accepted by FIERAMENTE may be subject to refusal by the courier.

1.1 In the event of loss or damage to the aforementioned parcels, FIERAMENTE will, on behalf of the customer and through an out-of-court process, request compensation from the courier. The customer expressly agrees that FIERAMENTE shall not be obliged to take any further actions, including legal proceedings, against the courier and that FIERAMENTE's only obligation in case of loss or damage to the parcels shall be that stated in the first part of this article.

2. FIERAMENTE does not accept deliveries of materials that are non-transportable by the courier. To this end, the customer declares that the delivered goods do not fall into the category of non-acceptable and/or non-transportable items as defined by the courier and acknowledges that the courier's packaging standards have been communicated by FIERAMENTE.

3. FIERAMENTE is responsible within the limits of the declared value by the customer for packaging operations (only if performed by FIERAMENTE), safekeeping, and delivery of the parcel to the courier.

4. Except in cases of willful misconduct or gross negligence, FIERAMENTE's liability is governed by the following conditions:

4.1 FIERAMENTE does not assume responsibility for the successful transportation of the accepted parcels nor for the loss or damage of their contents, regardless of the cause. FIERAMENTE is not responsible for any refusal of payment by the courier and shall not be liable for reimbursement of damages. Compensation for loss or damage is limited to the maximum amounts established by Legislative Decree No. 286 of November 21, 2005, and subsequent amendments for shipments within Italy, or by the Warsaw Convention of October 12, 1929, and subsequent amendments for air shipments, or by the Geneva Convention of May 19, 1956, for international road shipments.

4.2 FIERAMENTE does not assume responsibility for damages to parcels packed by the customer. The courier's liability for parcels packed by the customer is limited to cases of loss, not damage, unless the customer has opted for insured shipping, if available, in compliance with the specific conditions provided. In case of insured transport, the courier assumes liability only for the repair or replacement value based on the declared and duly proven value, except for services with specific conditions.

4.3 FIERAMENTE does not assume responsibility for the timely delivery by the courier. Any statement made by FIERAMENTE staff regarding the estimated delivery date is merely an opinion. FIERAMENTE is not responsible for shipping delays caused by the courier.

4.4 In case of cash-on-delivery payments, FIERAMENTE assumes no responsibility for potentially irregular, counterfeit, insufficient, and/or incorrectly completed bank drafts and/or cashier's checks issued by the recipient.

4.5 For shipments involving taxes, customs duties, charges, and/or other transport-related costs, these must be paid by the customer.

4.6 If the customer has chosen insured shipping, FIERAMENTE assumes no responsibility for the denial of reimbursement in cases where the customer has failed to follow the prescribed instructions provided by FIERAMENTE for submitting the required documentation for the potential processing of the compensation claim.


